

The project « **Posting of workers : strengthening and deeping international cooperation 2023-2024** » is funded by EU.

Continuing the «Eurodetachment» approach, it is the 6th European project coordinated by **INTEFP** and **ASTREES**.

The project follows a sector-based approach, focusing on **construction, agriculture** and **temporary work** sectors.

It involves **16 Member states**, **4 European Social partners federation** and **European Trade Union Confederation**.



The general objective is to contribute to a better implementation of the **Directive 96/71/CE** (posting of workers in the framework of the provision of services) through :

- Improving the efficiency of transnational administrative cooperation
- Strengthening at the national level collaborations between different stakeholders of posting operations
- Enhancing synergies between public authorities, and/or social partners

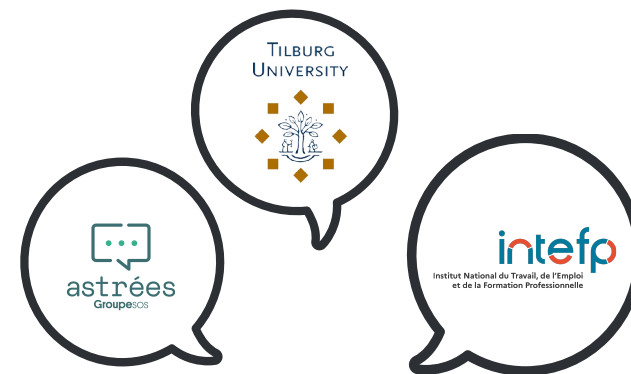

JOINT DESIGN

OF «COOPERATION PLANS»

From March 2023 to May 2023, the first stage is assigned to project partner's representatives, gathered in a steering committee. The process goes through identification of situations on both sides of the border, definition and planning of actions, building **transnational teams** of professionals.

«COOPERATION PLANS» IMPLEMENTATION

The second stage is running from **May 2023 to the end of May 2024**. Implementation stage could involve labour inspectors, liaison offices, other public authorities (social security, tax administration) and social partners.

CAPITALISE AND SHARE THE INITIATIVES

Based on involved teams' reports, a **sharing workshops** gathering all participants in cooperation actions is scheduled in **from March 2023 to May 2024**. The objectives of these workshops are to share implemented actions' results, good practices in information exchange and innovating initiatives in data sharing.

All these actions will nurture the **project final conference** scheduled in **June 2024**.
